Law reform initiatives in regard to cross order insolvency proceedings have been promulgated for the last decade. In response, the United Nations Commission on International Trade Law developed the *Model Law on Cross Border Insolvency Law* in 1997 which was adopted by the United Nations General Assembly in December of 1997. In 2005 the United States enacted Chapter 15 of the United States Bankruptcy Code which incorporated the UNCITRAL *Model Law on Cross Border Insolvency*. In 2006 the United Kingdom enacted and made effective Article 15. Sixteen countries have now adopted the *Model Law*. In 2004 UNCITRAL completed its work on the *Legislative Guide on Insolvency* which provided a guide for insolvency law reform for states. UNCITRAL is now developing guides for Corporate Groups, Post-Commencement Finance and Protocols. The presentation will address these initiatives and how their utilization will affect the practitioner in the United States.
